### Rogers weakens below moving average price Wednesday June 25, 2025 16:00 EDT

Rogers Corporation's (NYSE: ROG \$68.45) stock price decreased 34.0c (0.5%) from its previous trading session to close at \$68.45.

The 200-day Moving Average Price (MAP) is \$87.36, down from \$87.45 on Tuesday. The price to MAP ratio is 0.78.

In the past month the MAP has exceeded the share price on 21/21 days; another bearish signal.

There were 86,200 shares worth \$5.9 million traded today; the volume was 0.5 times the average daily trading volume of 171,875 shares.
