Eventbrite drops 2.6% on increasing volatility Monday June 30, 2025 16:00 EDT

Eventbrite Inc's (NYSE: EB \$2.63) stock price traded between an intraday low of \$2.62 and a high of \$2.80, suggesting a trading opportunity between peaks and troughs.

Eventbrite's stock price fell 7.0c (2.6%) from its previous trading session to close at \$2.63.

Compared with the S&P 500 Index which rose 31.9 points (0.5%) in the day, the relative price change was -3.1%.

There were 625,800 shares worth \$1.6 million traded today; the volume was 0.5 times the average daily trading volume of 1.3 million shares.

Eventbrite (NYSE:EB), announced total revenue of \$73.8m for the quarter-ended 31 March 2025 [Q1/2025], down 3.4% from the previous quarter [Q4/2024] and down 14% from the year-earlier period [Q1/2024].

Bearish Signals

Price/Moving Average Price:

- The Price/MAP of 0.91 for EB is lower than the Price/MAP for the S&P 500 lndex of 1.08.
- The price to 200-day MAP ratio is 0.91, a bearish indicator. In the past 200 days this ratio has been under 0.91 198 times suggesting further downside. The 50-day MAP of \$2.36 is lower than the 200-day MAP of \$2.88, another bearish indicator.

Relative Strength (6 months):

- In the NYSE market of 1,913 stocks and 37 units traded today, the stock has a 6-month relative strength of 14 indicating it is trailing 86.0% of the market.
