

# Eventbrite (EB: \$2.25)

# Eventbrite closes at 5.5% above VWAP Thursday April 17, 2025 16:00 EDT

Eventbrite Inc's (NYSE: EB \$2.25) stock price gained 9.0c (4.2%) from its previous trading session to close at \$2.25.

Compared with the S&P 500 Index which rose 7.0 points (0.1%) in the day, the relative price increase was 3.9%.

The price is at a premium of 5.5% to the 1-month Volume Weighted Average Price (VWAP) of \$2.13.

There were 581,206 shares worth \$1.3 million traded today; the volume was 0.3 times the average daily trading volume of 1.9 million shares.

In the past five days trading has been on consistently low volumes; Volume Index (VI) has been 0.6 or lower.

Eventbrite (NYSE:EB) reported gross profit for the year-ended 31 December 2024 [FY2024] of \$227m, up 1.6% from \$223m in the previous year [FY2023].

## Past Week:

- Eventbrite is placed 102/2281 in BuySellSignals' ranking of NYSE performers in the past week, a percentile ranking of 96.
- In the past week, volume was 0.4 times average and the shares were up 10.3%. Thursday's close price is at a 3.2% premium to its 5-day Volume Weighted Average Price (VWAP) of \$2.18.
- The stock posted rises of more than 4.1% on 2 out of 5 days in the past week of trading. The top rise was 6.2%.

## Undervaluation [compared with sector average]

#### Price to Sales:

- Price/Sales of 0.7 [3.1]. We estimate Eventbrite stock is trading at a current year Price/Sales of 0.6 and a forward year Price/Sales of 0.5.

## MCap/Total Assets:

- Tobin's Q Ratio, defined as MCap divided by Total Assets, is 0.3. Compared with the rest of the market the stock is undervalued and ranks in the top quartile of stock by value of Q Ratio.
